



Lake Claire Greenspace Acquired by City of Atlanta

Lake Claire's City Councilwoman Natalyn Archibong recently announced that the City has acquired undeveloped land on Harold Avenue as permanent green space. The half-acre tract is on the east side of Harold where it intersects with Muriel Drive. The tract borders the Frazer Center Forest, is crossed by a spring-fed creek that is a source of Peavine Creek, and is home to many mature hardwood trees.

The story of how Lake Claire became the beneficiary of such wonderful space began simply. In January 2003, Lake Claire resident Kathy Evans was strolling her son through the neighborhood when she noticed large red X's, signifying imminent destruction, on almost every mature tree on the tract: "I never like to see trees being removed if it isn't necessary, but when I saw all the red X's on the trees so close to the banks of a stream and at the edge of this incredible urban forest, I immediately thought, someone has to do something to prevent this." In talking with friends and neighbors, she realized she was not alone in feeling that the proposed development was too insensitive to the environmental riches of the property.

A nearby neighbor, Chad Pollazzo, had already nominated the property for DeKalb County's green space program with the support of Robert Reed, the owner of the property, but the County had not completed its evaluation when the red X's appeared. Evans and other neighbors collected over 100 signatures on a petition calling for more environmentally-sensitive development than the proposed plan of three large homes that would require removal of most mature trees and overly stress the stream.

A core group of neighbors met with Reed and tried to find a compromise for development that would not be as devastating to the mature trees and stream. The neighbors filed an appeal with the City's Tree Conservation Commission while continuing

dialogue with Reed. Shortly thereafter, the City realized that it erred in granting a building permit for three homes. The tract consists of only two legal lots and a former city right-of-way that the City had sold to Reed. However, without a variance, the portion of the tract that was the former city right-of-way did not meet current zoning regulations for a buildable lot, and the director of the Bureau of Buildings placed a hold on the permit. Reed appealed that decision to the Board of Zoning Appeals. More than a dozen neighbors turned out to support the City in the appeal and the Board upheld the City's decision. The neighbors and Reed continued to seek a compromise solution and engaged in several weeks of mediation with the Neighborhood Justice Center in Inman Park, resulting in an agreement in principle that called for the building of two homes on the parcel.

During this same time, neighbors who had long appreciated the forested acres of the Frazer Center began to talk about how they had wanted to do something about the increasing erosion and invasive plant problems in the forest. Under the leadership of Dan White, president of Lake Claire Neighbors, and with the assistance of Kathryn Kolb, a local nature photographer and naturalist, LCN founded Friends of the Frazer Center Forest to work with The Frazer Center to develop and implement a management plan for their urban forest in our midst.

To launch their efforts, the Friends of the Frazer Center Forest and LCN, co-hosted an Urban Forest Seminar to heighten awareness about the benefits of urban forests and to learn more about how to best restore and preserve the Frazer Center Forest. Councilwoman Archibong was represented at the seminar by staffer Kristina Garcia-Bunuel. After learning more about the storm water runoff challenges of the neighborhood and forest and walking the Harold Avenue parcels, Garcia-Bunuel realized that the most appropriate plan for the site would be permanent

preservation. She took her insight and enthusiasm back to Councilwoman Archibong, who began working with the City to repurchase the right-of-way the City had sold to Reed, and to purchase the two lots as well. Archibong's collaboration with The Conservation Fund and Reed resulted in a mutually-beneficial agreement that permitted the City to buy the tract at fair-market value and allowed its preservation as permanent green space. Although Reed is a little disappointed in the final economic return in comparison to what would have been realized had homes been built on the property, he is nevertheless "very pleased" that the property will remain green space. The Friends of the Frazer Center Forest were ecstatic and within days of the announcement that an agreement had been reached, were out with their tools beginning to reclaim the new green space adjacent to the forest from the ivy and kudzu.

Evans is thrilled that the site will be permanently protected and is grateful that the perfect combination of factors came together – dedicated neighbors, a willing property owner, and Councilwoman Archibong, whom she describes as "a forward thinking public official who recognizes the very important purposes of green space beyond its traditional recreational uses — filtering stormwater runoff, providing space for mature trees, protecting water quality, and adding to the city's green infrastructure." Although Evans describes the task of reclaiming the site from invasive plants as daunting, she and White are hopeful that it will be restored and be a showcase of native plants that the neighborhood and City may enjoy.

While they work toward that goal, Evans and White remain grateful for the efforts of the people who brought the process this far. Evans finds inspiration in "the individuals who worked so hard toward the protection of this space – Elizabeth Hamilton, Kathryn Kolb, Terri Stewart, Roger Swift, Sarah Wynn, Kristina Garcia-Bunuel – and all the other neighbors and friends who supported the efforts and who are continuing the positive work for our local environment as a part of the Friends of the Frazer Center Forest." White too is encouraged by the long process that began so simply, "I learned that a committed group of neighbors working consistently on an issue over time in collaboration with a responsive elected official can produce a positive outcome to almost any problem."

Lake Claire's President, Dan White, sent this letter to Councilwoman Natalyn Archibong in response to the news of the greenspace acquisition.
Dear Natalyn,

On behalf of the residents of Lake Claire I would like to thank you and your entire staff for the all your efforts in acquiring the tract of land on Harold Avenue as green space to be protected and preserved forever. Our two year struggle to stop inappropriate development has culminated in an outcome no one even thought to consider at the outset of this process.

The dedicated efforts of neighborhood residents working closely with you and your staff have saved all the mature hardwood trees as well as safeguarded the spring fed stream that originates on that site. The possibilities to demonstrate low cost storm water management techniques, the possible creation a living laboratory for the planting of native flowers and shrubs, and the preservation of the Frazer Forest corridor to Harold Avenue are immediate and potential achievements we can all celebrate. We in Lake Claire look forward to future collaboration with you on similar efforts within district 5.

Letter to the Editor

We have resided at 622 Harold Avenue in Lake Claire for over 15 years. We are active volunteers in community, school, church and neighborhood issues. It is our understanding that developers are currently targeting our close neighborhood with the goal of demolishing existing homes and replacing with "Hummer" houses, also known as "McMansions."

We are not adverse to new home construction nor change per se, but strongly oppose the disturbing trend to build out-of-scale, super-sized houses that are grossly disproportional to the existing homes of our lovely wooded urban neighborhood. It is regrettable that modest homes in excellent condition may be demolished and replaced with new structures on steroids. Just as Hummer vehicles have come to symbolize wasteful consumption, boastful greed and super ego, so too do the Hummer houses that stand as distorted mismatches and exploitations of what is reasonable for our mutual well being. This practice is strongly opposed by many existing neighborhood residents and under current review by the Atlanta City Council.

Maxing out lot coverage in this fashion results in, with few exceptions, old growth tree removal and distress, habitat elimination and watershed drainage problems for the surrounding dwellings. It creates ill will and alienation amongst neighbors. Several homes recently built in the neighborhood with this approach have resulted in almost complete tree loss, water

damage to adjacent homes, and litigation between neighbors. Short of the quick and substantial profit for developers and realty agents, most will concur that there appears to be absolutely no upside for our community.

We are hopeful and optimistic that our neighborhood properties can be profitably and reasonably developed with sensitivity to the surrounding neighbors for the benefit of all who live here. From the outset, we recommend adjoining property owners establish a dialogue with developers to avoid potential conflicts. However, just as the sellers and buyers have rights, so do we as affected surrounding residents.

We must and will exercise our rights in monitoring adherence to all applicable codes, enforcement and fees involving, but not limited to, proper site development, demolition, tree removal/impact/recompense, grading/elevation, watershed/drainage, building permit, height restrictions, lot coverage/impervious surfaces, noise ordinances and of course any direct damage to our property.

As they say, we all live downstream.

We look forward to and welcome sensible development in Lake Claire, our home, and to developers that can still sleep at night.

Crime Information Website

The news lately has been filled with reports of young children kidnapped, molested, and killed, allegedly by persons who had prior convictions for sexual crimes against children. A recent search of a Georgia Bureau of Investigation website revealed that there are nine individuals living in DeKalb County in zip code 30307 who have prior convictions for sexual assaults. Sexually violent offenders who have been placed on probation, parole, supervised release or released from prison after July 1, 1996 are required to register their residence, employment, or school address with the Sheriff’s office. This information is available to the public on a Georgia Bureau of Investigation website at <http://www.ganet.org/gbi/disclaim.html>. A sexually violent offender is a person who is convicted of a criminal offense against a victim who is a minor or who is otherwise convicted of a sexually violent offense. A person may search the website by City, County, zip code, or by the offender’s name. The website will give the offender’s name, a description, sometimes a photo, address, type and date of conviction. Due to the fact this information is continually changing, the Georgia Bureau of Investigation makes no expressed or implied guarantee concerning the accuracy of this information.
