The Lowdown on Clifton's Slowdown

The newly-formed Pedestrian and Bicycle committee of Candler Park Neighborhood Association, chaired by Richard Ford, hosted a meeting on February 9 at Epworth Methodist Church on McLendon Avenue to discuss potential traffic calming options for Clifton Road. It had been described as a follow up to a PEDS-sponsored meeting at Mary Lin back in September of 2005.

Clifton Road concerns both Lake Claire and Candler Park since the road straddles both communities, involves two



City Council districts, and any changes to Clifton could positively or negatively impact nearby residents on Harold, Hardendorf, Page and Clifton Terrace.

With very short notice, several concerned residents on Clifton and surrounding streets called dozens of their neighbors, sent hundreds of emails, and distributed over 600 flyers on Clifton and the surrounding streets. Attendance was estimated at 80 to 100 people. A show of hands revealed a healthy balance of folks from Candler Park and Lake Claire. Residents of Clifton Road were a sizable part but not a majority of the attendees. Also included were representatives and cyclists from SOPO (a bicycle co-op), the Southern Bicycle League and the Atlanta Bicycle Campaign. The sign-in sheet, with phone numbers and email addresses, was left with Ford after the meeting, so a count of names must await his announcement.

The meeting began with a presentation by Dianne Olensky of PEDS and focused on the use of medians and on how the road might be carved-up among its various uses. In the past PEDS has suggested narrowing Clifton using medians and/or bulb-outs, even though lane narrowing is known to pose problems for cyclists. Several residents fundamentally disputed Olansky's conclusion that a "consensus opinion" had arisen at the September 2005 meeting supporting medians along Clifton Road. The PEDS summary simply was not what many recollected as the outcome of the September 2005 meeting. It was of opinion that stop signs - not medians - had been the favored approach.

As the meeting became heated, the city's traffic engineer, Lorne Whitaker, began explaining the policies of the city regarding traffic calming, stop signs and a recent speed study for Clifton - which showed an 85 percentile speed of 41 mph. For bicycle safety, the city prefers 14-foot widths if cars and cyclists share a lane. Presently, the lanes on Clifton

are 13 feet wide and are part of the PATH bike route. The proper taper of medians (15 feet of taper per single foot of width) was also highlighted, with Whitaker explaining that a 4-foot wide median would require 60feet of lane taper. Lots are typically 50-feet wide, so a 4-feet wide median would produce the loss of on-street parking for at least the residents of each corner lot, and perhaps a bit more. Whittaker emphasized that the city would insist on meaningful resident involvement in the process, noting as an example that major changes could require a petition showing support for further consider-

ation by at least 75 percent of the Clifton Road residents.

There was no official vote taken at the meeting, but Whittaker presented several non-controversial steps that would be undertaken by the city. These steps, as confirmed by Karen Brown of Lake Claire after the meeting, were: (1) The side lane stripping on Clifton Road is to be completed; (2) ADA-compliant curb cuts installed at crosswalks: (3) the installation of center- street pedestrian signs; and (4) undertaking a study of traffic speed and volumes after steps 1 to 3 are completed to learn what had changed. Concerning any potential medians or stop signs, Whittaker assured that if they are to be used, the city would provide a clear answer on stop signs and drawings to scale of proposed median designs. Whittaker said after the meeting that it would likely take up to 4 months before these tasks could be accomplished.

The Conscientious Gardener

from the Lake Claire Gardening Club

What (or who) is a "conscientious gardener"? One who considers the impact of their plans and actions on the environment and on their neighbors. For example:

Will a plant you install obstruct a driver's view of traffic or pedestrians as they attempt to back out of their driveway? Will removal or installation of certain plants affect the predominance of sun or shade in a neighboring garden? These and other questions can have safety, practical, as well as aesthetic ramifications. As you plan your personal paradise, ask yourself how you would feel about the plan if you lived on the

other side of the property line. Another topic that affects the neighboring yards is weed control. Are you seeding the block? A well-timed application of a quality weed'n'feed product may solve the problem. Do you have dead limbs hanging over utility lines or neighbors' property? Get them trimmed. Be aware of invasive plants migrating from your yard. Species such as English Ivy can be particularly difficult and annoying.

There is no question that Atlantans love their gardens. In fact, Lake Claire has its own Garden Club, a delightful

Special Note: Please be aware that the apparent suspects involved in the four separate pedestrian robberies at gunpoint and the armed robbery of Zesto's reported below are in police custody. 

Notes from January 26, NPU-N meeting

- * If you have trouble getting a response from the City regarding a sewer leak or road repair associated with sewer repair, call Janet Ward, 404-330-6131, in the Department of Watershed Management.
- * At least four armed robberies have occurred in the area involving pedestrians, two in the 1500 block of McLendon Ave. and two near Oakdale and Dekalb near the Candler Park MARTA station. Two brothers (ages 15 and 17) have been arrested and some of the stolen goods were recovered from their home. They also implicated two other people, who may drive a white Ford Taurus. Police are seeking the other two suspects (as of Jan. 26).
- * Brian Stone, a Lake Claire resident and professor in the College of Architecture at GA Tech, was appointed to join the Olmsted Linear Park Association (OLPA) board as the Lake Claire/NPU-N liaison.
- * The Olmsted Linear Park Association (OLPA) recently received a \$1 million grant from the Department of Transportation for the renovation of Deepdene Park, the last of the linear parks on Ponce de Leon to be renovated. OLPA requests that witnesses report anyone seen damaging light posts or dumping mulch in the linear parks so that a police report can be filed. Approximately ten white oak trees in the park near Clifton Road and Ponce de Leon soon will be removed under the direction of OLPA and the City of Atlanta (street trees) because they are dying and have an infestation of ambrosia beetles. The new playground at Springdale Park currently is fenced until the drainage area adjacent to it can be landscaped.
- * Comprehensive Development Plans (CDPs) should be amended to include new projects requesting funding under Recreation and Greenspace Bonds (\$110 million). The CDPs will be discussed in public meetings in May and will be reviewed by the Commissioner's Council on Parks and Greenspace.
- * Housing code enforcement questions should be directed to Ronald Scott or Anita Hale at 404-330-6131. The Office of Code Enforcement also is initiating a citizen Deputy program for reporting Code Enforcement Concerns. Inquire with Ronald Scott.

- * At-large City Councilmember Mary Norwood spoke about proposed infill building regulations to regulate the size and height of infill building. The City Council will vote on February 6 on whether to implement a 120-day moratorium on out-of-scale infill in several neighborhoods, including Lake Claire. Proposed new regs will be distributed and voted on in neighborhoods in February, NPUs in March, and the Zoning Review Board in April. (This proposal failed to pass Council approval, but an Infill Task Force will reconvene to review changes to the Zoning Ordinance to help address concerns about inappropriate infill).
- * Partners Capstone, Inc. seeks a rezoning of 288 & 292 Gordon Avenue in Lake Claire from C-2 (Commercial Services) and RLC (Residential Limited Commercial) to MR-3 (Multi-Family Residential) to build 13 condominiums on .5 acre. Request deferred until February. (Now postponed for review at March 16 Lake Claire Neighbors meeting).

Reroofing and Uprooting Improve Lake Claire Park

Lake Claire Park has seen many improvements over the 2005, the most recent being upgrades to the picnic pavilion and the removal of kudzu and other invasive on the north end of the park bordering McLendon Ave. Thanks to Nabil Hammam for coordinating the installation of a new roof to replace the rusted metal on the pavilion. The choice of slate grey architectural shingles really improves the look of the pavilion and makes it a much more inviting place to have that picnic lunch. Other improvements coming are painting the columns, new railings, picnic tables. Lake Claire Garden Club is planning to landscape the area with native plants as well.

Terry Sutton has been contracted by LCNA to remove kudzu and other invasive plants in the wooded area south of the pavilion. This is an initial treatment that will continue till early summer when it is hoped adjoining neighbors and the park committee will organize efforts to maintain this effort funded by LCNA, Park Pride, and the Lake Claire Garden Club. A similar effort is underway on the Harold Avenue Greenspace parcel as well. We invite all neighbors to walk to either natural areas and enjoy the improvements.





Takes Many Hands to Make a Mural!

The Watershed Mural has been an ongoing project for the past several years, organized by Lake Claire Neighbors. The first period involved grant writing and research, with several months of community presentations about the value of urban forests and their relationship to water quality, and solicitation of design ideas. Expenses include commissioning David Fichter, one of the leading muralist in the country to design and oversee the painting of the mural, travel costs for Fichter, support from a local professional artist, printing of informational materials, acrylic paints, special anti-graffiti sealers, sign board for mural "cut-outs" that will be applied to the wall, and rental of scaffolding, levelers, etc.

Mural Work Continues

A tremendous amount of work was completed in January on the Dekalb Avenue Watershed Mural, and prep work continues for our next big push, scheduled for April.

Thanks to David Carter and Robin Singer who volunteered their carpentry skills to cut out the wooden (sign board) white oak tree that will be placed at the center of the mural. The tree and other cut-outs will provide dimension and additional height to the mural, enhancing the overall design. The tree will rise above the wall, creating a canopy under which surrounding neighborhoods, including Lake Claire, Edgewood, Kirkwood, and Candler Park will be silhouetted, orienting the viewer to Dekalb Avenue where the mural's story begins.
