Happy Earth Day Gift for Lake Claire

Lake Claire has a new greenspace just in time for Earth Day! The wooded parcels, adjacent to The Frazer Center Forest on Harold Avenue, are home to the headwaters of the Fernbank Fork of Peavine Creek, numerous hardwood trees, and lots of wildlife, and were officially added to the City's inventory of preserved greenspaces in March. Lake Claire Neighbors will manage the "Harold Avenue Greenspace," for watershed protection and passive use, under a MOU with the City.

Many thanks to the scores of residents who recognized the ecological importance of the parcels, attended meetings with the owners, talked with City Council, wrote the Mayor, trekked to a Council meet-


ing (a record 100+ LC homeowners!), and generally supported the effort. After nearly four years, the process is now final and the results are tangible -- a small but very important piece of land adjacent to 35 acres of

old growth forest is preserved. Stroll by and listen to the birds sing! We are grateful for the hard work and dedication of our City Councilwoman, Natalyn Archibong, who made the purchase possible. She went more than the extra mile to support the wishes of her constituents (us!) and to protect the environment. We also are grateful to The Conservation Fund, which facilitated the purchase, and to the property owners who were willing to sell the land for the purpose of preservation.

We plan to celebrate with a street party in front of the greenspace in the Fall!

Think Globally, Refuel Locally: Biodiesel

In January 2006, Rob Del Bueno of Southern Alliance for Clean Energy (SACE), a nonprofit nonpartisan organization promoting responsible energy choices, presented plans for a biodiesel filling station at a Lake Claire Neighborhood Association meeting. Since then, Rob has made progress on the filling station and other biodiesel operatives in Atlanta. When I spoke to Rob to get the latest on the station, it was clear that he's passionate about providing biodiesel locally to make an environmental impact.

What's in the tank? Rob gave a biodiesel primer, touching on chemistry, economics, and engineering. For more information, go to Cleanenergy.org, Grist.org, or Biodiesel.org (Official Site of National Biodiesel Board).

"Biodiesel" is different from "Petrodiesel" in that the former gets its energy from recent plant life matter (e.g. vegetable oil) while the latter is animal/plant matter converted to oil after millions of years of heat and pressure. Biodiesel can easily blend with petrodiesel to form B10, B20 ...B100. The number refers to the percent of biodiesel. For example, Rob blends biodiesel with petrodiesel to power Emory's bus fleet with B20. Emory first tried B5, then graduated to B10 and now utilize B20. Eventually, Rob would like the buses to run on B100 using Emory's own used fry oil in a closed loop system.

on the FPC board and step into the role of neighborhood representative when her volunteer period expired in October of 2007.

- Kathy Evans talked about the volunteer position available as the neighborhood's rep to the NPU.
- Tish Ganey has volunteered as new Clarion layout volunteer.
- Glenn Frankel spoke about neighbors renewing their membership and explained that this could be done on-line through the paypal link that he setup.

Officers reports:

- Treasurer, Diane Moore, reported that accounts are steady.
- VP Zoning, Dan White, provided land use updates as follows:
- 1. 288 and 292 Gordon Avenue variance request to reduce side yard setback between commercial and residential property from 20 feet to zero to construct 10 town homes; voted in Jan. by LCN: 22, no; 8 yes. (Variance v-313-06) will be heard at BZA Feb. 16;
- 2. Request to rezone 2068-2100 DeKalb Avenue (9 residential properties on DeKalb at Howard Circle) from single family to MR3 to build 40 condominiums; presented as info only to LCN in Jan. POST-PONED until further notice.

Land use:

1. Dan White presented slides of 545 Clifton Road, where homeowners request a variance to construct an addition. The presentation was given by the architect, Cynthia Karegeannes. The request was for a variance (#V0724) to reduce side yard setback from required 17.5 feet for corner lot to 3 feet for second floor addition, and to 7 feet for 20-foot rear addition. LCN unanimously voted to support variance (51-yes), with the condition that driveway and parking pad be constructed of pervious material to limit the increase of impervious surface area on the property and therefore reduce storm water runoff.

2. Following the variance vote, a discussion of plans to construct a pool on the Horizon School property at 1900 DeKalb Avenue took place. Dan White explained that he had recused himself from previous discussions of this site, citing his membership on the City of Atlanta Tree Commission as a conflict of interest, but could now participate in discussion since the appeal to review the tree plan had been withdrawn. Scott Dunn, one of the developers of the pool along with two other pool representatives, answered questions and addressed neighborhood concerns regarding the proposed pool development. Miscellaneous Items discussed:

A neighbor inquired about the helicopter flying over the neighborhood with floodlights. Dan Wright, VP Public Safety, said it was a routine practice and that neighbors should not be concerned.



The Making of a Mural

Three years ago, current Lake Claire Neighbors president Kathy Evans developed the idea for a watershed mural along DeKalb Avenue. Shortly thereafter, she discussed her idea with long-time Lake Claire resident Bill Fleming, who, unbeknownst to Kathy, had been involved in several

mural projects in the past. Bill enthusiastically supported the idea, saying "let's make it happen -- I know just the muralist to do it." Kathy and Bill proposed the idea to the Lake Claire Neighbors, which also offered enthusiastic support.

Soon after the neighborhood association decided to pursue the project, Bill left for Wales to pursue a graduate degree. Kathy began successfully writing grants to fund the project, and the DeKalb Avenue watershed mural has blossomed from a dream to reality because of her untiring energy and inspired leadership. Kathy worked extensively with the muralist, David Fichter, wrote additional grants to fund the project, spoke to numerous different school and community groups about the effort, recruited volunteer painters, and more. No other LCN project has required the coordination and engagement of so many volunteers, so many hours of labor, so much cooperation from all segments of the community, and so much sheer determination.

The DeKalb Avenue site for the mural presented a





creative challenge for muralist David Fichter and a physical challenge to all who worked there. Averaging a height of 12 feet and a length of over 400 feet, this mural is one of the largest public art displays in the city. Speeding traffic, heat

and cold, little shade, and blustery winds required a significant physicalcommitment from those contributing their time, creativity, and artistic expression to this massive undertaking. And Kathy was there every day of the planning and painting to help set up and break down the work stations and secure the equipment, not to mention adding her own brush











strokes to David's design. She was also instrumental in suggesting people and places, flora and fauna to be included in the mural, and in finding subjects to pose as models for some of David's ideas.

As truly beautiful as our mural is today, it is not just art for art's sake. It tells a story often overlooked in our urban world, that of our connection to the natural world and all who live downstream. The DeKalb Avenue Watershed mural teaches us about our environment, inspires us to be better caretakers of our resources, and beautifies our transit corridor




Kathy Evans: "Neighborhood Friend and Coordinator Extraordinaire"

Our community is the sum of things in our neighborhood--our homes, pets, gardens, parks, and of course, our neighbors. Indeed, the people in our neighborhood exert the greatest influence on the feel of our community. And some can influence and change the community itself. Kathy Evans is the poster child of a community member who influences and changes the community for the common good. While she's known for her kindnesses in small ways-picking up groceries for a sick neighbor or rescuing a dog in the rain, the Watershed Mural on DeKalb Avenue is a great example of community change spearheaded by Kathy. Although the accompanying article details her efforts to build the mural, her son Logan captured the essentials: "My mama wanted to make a mural to teach people about the watershed. She is a great teacher. She worked hard to make the mural and get other people to help make it." But the mural is just a glimpse of Kathy's recent accomplishments. Let's switch gears to the back roads of Kathy's life

A seventh generation Georgian, Kathy was born





in Milledgeville in 1964. She lived in Gordon, Macon, and Morrow before moving to Conyers when she was in the third grade. As a child, Kathy loved spending time with her extended family in the rural counties just east of Macon. She spent many summer days in Irwinton, hiking to Bear Camp Lake and beyond. Kathy first saw the ocean on beautiful Jekyll Island, which she is now working to protect from over-development.

When it came time for college, Kathy opted for the three year plan. She spent one year at Oxford College of Emory University and the next two at Emory, graduating in 1985. She studied epidemiology as a graduate student at Emory, receiving a Master of Public Health degree in 1992.

In 1988, Kathy and her partner, Susan Casey, Continued on Page 11

bought their first house in Lake Claire. They left Atlanta in 1993, moving to Austin, Texas for three years, and then on to Chicago for five years. In Austin and Chicago, Kathy worked in the environmental health field and volunteered in her communities, working for the re-election of Ann Richards in Texas, and serving as a Guardian Ad Litem in Chicago.

In the summer of 1999, Kathy's and Susan's son Logan was born and the next year, the whole family moved back home to Lake Claire. Kathy became a full-time mom upon returning to Atlanta, but also got busy protecting the environment in Atlanta and beyond, helping other people, and creating beautiful things like murals! She has been a very active community member: Founder and Advisory Committee, "Keeping It Wild;" Founder and Keeper, "Friends of the Frazer Forest;" and several positions on the executive committee of our neighborhood association, Lake Claire Neighbors, including her current role as President. She was also instrumental in the City's acquisition of the Harold Avenue greenspace.

Her dedication to the community was recently recognized by the Atlanta Planning Advisory Board, which honored Kathy with the 2006 Community Service Award for Neighborhood Planning Unit N and specifically cited her work with the mural.

Even though she's involved in many different projects and groups, Kathy Evans knows how to have fun. Kathy enjoys gardening and loves to go hiking, canoeing, stargazing, beachcombing, and bird/animal watching — anything that involves being out in the natural world. Her favorite food by far is Thai, and her favorite vacation spot is

Joseph, Oregon (or, wherever she last went and spent a lot of time outside!).

Many people will start something and not finish; not so with Kathy Evans. She is able to go full throttle without losing any steam or enthusiasm. Thanks for being who you are Kathy!






62, 63, or 64 years old?

Lydia is conducting a research study at Emory to understand how people learn about Medicare's new prescription drug benefit and what their opinions are about it.
