Letter to the Editor re: Infill Development

I was disappointed to read an article by a real estate agent, who is not a Lake Claire resident and who was given press time in The Clarion to promote further development of our neighborhood, including a "plug" as a real estate agent He and any other real estate agents, along with McMansion builders, who actively seek Lake Claire houses to be torn down or empty lots to be consumed, are surely grinning from ear to ear. This is no thanks to the building codes in Atlanta that allow McMansion construction in Lake Claire along with the lackluster reaction by Lake Claire residents to this type of construction in our neighborhood.

The latest McMansion built in Lake Claire, that I am aware of, was built fast and cheap with standard water heater, versus tankless on demand type and no solar components (passive or active) to conserve energy. There are two, not one, a/c condensers required to cool this particular house, churning away in what was once a quiet side yard. The turf was installed over drink cans and plastic containers left strewn in the yard. Many other recyclable beverage and food containers were many times over stuffed in a Herbie Curbie for the landfill, which is where the tear down house was relocated. I would describe this McMansion as energy inefficient, except for and likely new Star energy kitchen appliances and whatever R-factor for insulation.

Let's become a squeaky wheel at city hall, voicing the need for change of the current zoning regulations. Needless to say, I am very concerned with the trend in new house construction in Lake Claire. –Linda Maynard

Dogs on the Run... Again

Is this signage trumped by the DeKalb/ City of Atlanta ordinance that dogs are not necessarily required to be leashed (per Brian Maddox's letter in the Clarion)? As many other moms and I have seen while at the park with our young children, large dogs (and dogs of all sizes) often end up running through the children's play area knocking down and even cornering some children, as I have personally witnessed. Do the neighbors of Lake Claire think it would be beneficial to open a dog park somewhere in the neighborhood to end this recurring problem? We have plenty of green space,

Atlanta Citizen's **Review Board** Weighs in

The following statement was written in response to the Atlanta Citizen Review Board's frustrations with the progress that they have been able to make since the Board was established in 2007. The purpose of the Board is to investigate allegations of misconduct by the Atlanta police and corrections departments. The ordinance establishing the Board gave the Board authority to investigate allegations of misconduct and to issue recommendations to the Chiefs, the Mayor and the Council. The ordinance specifically directs all employees to cooperate with investigations. Despite the unequivocal language of the ordinance, the police department has not complied promptly with requests for information. The Law Department has initiated a proposed revision to the ordinance and police officers have refused to answer questions from the investigator assigned to gather information after a complaint is received. The Committee on Council has not issued a subpoena as they are authorized by ordinance to issue in order to remedy the problems associated

including undeveloped areas of Lake Claire Park, the Harold Ave. green space, and the Land Trust. Would anyone be interested in establishing a park just for dogs in any of those spaces, or at least researching it?

As Alicia McGill pointed out in her letter, even "friendly" dogs can be triggered by something and will possibly attack. -Cecily Stevens

with information gathering. The budget for the Board is small and cannot sustain the costs of investigating all of the complaints without access to the police department's records.

Position Statement: Attempts to undermine Police Oversight

Some things are better performed in the dark. Police oversight is not one of them.

In the aftermath of the shooting death of Ms. Kathryn Johnston, the Atlanta City Council unanimously passed and Atlanta Mayor Shirley Franklin signed into law, an ordinance creating the Atlanta Citizens Review Board (ACRB), a model of citizen oversight of the police. The thinking was that if a 92 year old woman could be shot by the police in her own home and police would plant drugs in her home and cover up facts of the killing, what other acts of misconduct have been undiscovered and not investigated thoroughly by the Atlanta Police Department Office, the police branch responsible for investigating police misconduct. Citizen oversight of the police is now an established part of American policing and is virtually universal in other parts of the English speaking world. There is no single model and it is difficult to find two oversight agencies that are identical. Nonetheless, the City of Atlanta established an investigatory model that requires the police and corrections departments to promptly turn over information requested by the Board. The law allows the Board to seek a subpoena by petitioning the Atlanta City Council Committee on Council when the Police Department refuses to give the ACRB requested information. The Board receives and investigates complaints and can hold hearings in order to make recommendations to the Atlanta Chief of Police, the Mayor and the City Council.

The ACRB was pleased to announce in September 2008 that it was functional and actively accepting and investigating complaints against the Police and Corrections Departments. Complaints were received, investigations commenced, and the ACRB made requests to the Police Department for documents and records important to the investigation. Despite the requirement of the ordinance that it fully cooperate with the requests of the Board, however, the Police De-

partment consistently and repeatedly refused to provide requested reports, information, recordings and other records to the ACRB. In an instance involving the police shooting an unarmed man, the Police Department has refused to give the ACRB any requested information. Consequently, the ACRB in accordance with the ordinance petitioned the Atlanta City Council Committee on Council to issue a subpoena to the Police Department for the requested records. The Committee on Council refused to issue the subpoena and initiated measures to change the ordinance so the ACRB's access to information may be limited.

As a result of these developments, it is clear that, despite public proclamations by Atlanta's politicians that this Board would be given the ability to conduct meaningful oversight, the Atlanta City Council, Mayor Shirley Franklin, and the Atlanta Police Department itself, have consistently created barriers and obstacles to restrict work of the Atlanta Citizen Review Board.

The latest assault on the ACRB was hatched by the Atlanta City Law Department lawyers who represent the Atlanta Police Department. They have concocted a proposal to significantly limit the Board's ability to get information from the Police Department as the information is generated. Instead of the Board getting information as the Police Department produces it, the Board would only get information from the Police Department when it decides the Board should have it. So long as an internal Police Department investigation is open and if the information may be important to an open criminal investigation, the Police Department would not have to give it to the Atlanta Citizen Review Board. Police Department internal investigations and criminal investigations routinely remain open for years. Changing the ordinance would result in the ACRB not having access to need information for investigations probably for years. The ordinance change will effectively give control of the ACRB to the very agency that it was created

to oversee, namely the Atlanta Police Department. This is unacceptable. The Atlanta Police Department Office of Professional Standards began its investigation into the death of Ms. Kathryn Johnston over two (2) years after she was shot to death by police. With the proposed ordinance change, the Board would still be waiting over two (2) years after Ms. Johnston's murder for information held by the Police Department about this case.

The Atlanta City Council and the Mayor, responding to public outrage to the shooting and attempted cover-up by police of 92 year-old Kathryn Johnston, passed the ordinance creating The Atlanta Citizens Review Board. Their promise was that the Board would be given authority to provide meaningful oversight of the Police and Corrections Departments. This volunteer Board is comprised of 11 representatives from the community who have sacrificed tremendous time and energy and have given their expertise to develop a credible oversight and complaint system for the City of Atlanta. Now, when the ACRB is ready to perform real oversight, politicians and bureaucrats alike are fearful of true police oversight and are putting on the brakes. Atlanta Police Chief Penning-

ton, Atlanta Mayor Franklin, and now the Atlanta City Council (by way of the Committee on Council) have defied the ordinance and the will of the citizens. Police Chief Pennington and the Atlanta Police Department have consistently broken the law by refusing to comply with the ordinance. The Mayor, by way of the City of Atlanta Law Department, has actively assisted efforts of the Police Department to change to the law that would neutralize the Board. And, Atlanta City Council Committee on Council has refused to issue the subpoena needed for the Board to get information it requested from the Police Department. The Atlanta City Council promised the public an effective oversight system when it passed the law. It now is reluctant to enforce the very law it created. In order for there to be effective police oversight in Atlanta, the ACRB

must have prompt access to infor-

mation from the Police Department, as that information is generated and as mandated in the original ordinance. Any proposed change to the existing ordinance must fail. And, the Atlanta City Council must

express the will of the citizens by promptly issuing subpoenas when the Police Department withholds requested information and refuses to follow the law. A fair, credible and transparent oversight system needs the light of day. Citizens of Atlanta deserve real police oversight. The Atlanta Citizen Review Board is prepared to ensure fairminded, thorough and transparent police oversight, which will heal wounds and rebuild trust between the police and the community.

Barbecue To The Rescue

"We're just a group of guys that eat barbecue, drink the occasional beer and try to be better men." Kenyon Thweatt is talking about the Greater Atlanta Men's Barbecue Club and Support Group (GAMBBQC&SG). "There's no dues, no charter, no secret handshake....You just got to be a guy and show up," Vice President James Johnson adds.

The GAMBBQC&SG traces its origins to around 1999 when couples from Lake Claire and Candler Park with very young kids would gather at each others' homes for a "Happy Hour." Someone observed that the moms all had book clubs and so, in the name of fairness, the guys formed their own club.

Today, most are fathers whose kids attend Mary Lin Elementary, but more and more men are finding their way to Fox Brother's Bar-B-Q on Dekalb Avenue at 7:30 pm on the second Wednesday of every month. "They have the best fried okra around. It's fresh, whole okra, not those frozen little discs," Eric Dusenbury, the club's token vegetarian and a founding member, tells me over a beer. One of the other Erics, Eric Campbell, is the talent behind Wicked Que, a nationally ranked competitive barbecue team.

But if you get the idea that this is just a thinly veiled excuse for a bunch of guys to ditch the wives and kids for some serious man stuff, you'd be incorrect. "Yes,



the group is a lot of fun, but 'Support' is in our name and we not only support members, but the neighborhood as well." Kenyon says.

A few months ago, one member needed help constructing a fort for the kids in his back yard. The shout went out and he got what amounted to a modern day barn raising. The ranks of their "membership" range from doctors, lawyers and contractors to musicians and artists. "If we don't have one in our group, chances are someone has a friend who has what you need." Kenyon says. "We share tools, trucks and labor, and we're always ready to lend a hand."

The group occasionally leaves the neighborhood for semi-annual continuing educational purposes. Last fall, they took a tour of the Sweetwater Brewing Company (Lab & Lecture). The next Con. Ed. event will probably be at the Atlanta Brewing Company.

The group's big event is their annual golf tournament. The members split into teams and compete for a trophy. All the proceeds stay in the neighborhood. Last year the money went to Mary Lin Elementary. This year the proceeds were donated to Clifton Sanctuary Ministries, the residential shelter for homeless men at 369 Connecticut Ave. NE (www.cliftonsanctuary.com).

The Color Purple . . .

is blooming in the Freedom Park Bird and Butterfly Garden at the corner of North Ave., and Candler Park Drive. That purple is the larkspur, Delphinium L., a herbaceous perennial native to the eastern United States. Last month (April) Master Gardener Phil Edwards scattered some larkspur seeds in the garden and that burst of purple flowers is the result.

Larkspur prefer full sun, average soil and medium humidity. Some species of this plant can be toxic if eaten. Larkspurs are self seeding. Larkspur have some food and cover value for birds. It's also attractive to butterflies, including the Pipevine Swallowtail Battus philenor. Some Delphinium species are used as food plants by the larvae of some species of moth. The plants are pollinated by bees and butterflies. In herbal medicine its reported that the seeds can be used against parasites, lice and nits in the hair.. Larkspur has been thought to have been an effective Treatment for eye diseases.



A blue ink can be made from the juice of the flowers mixed with alum. It was used to keep witches from the stables In Transylvania, probably because of its dark color. Its scientific name is the Latin for dolphin, for the shape of the opening flower. Larkspur was called larks heel by Shakespeare.

I'm sure you all know we have an abundance of raptors around us – hawks of several varieties, and even owls. If you have very small animals, watch out for owls. Should you hear terrible screeching in the middle of the night, those are not ghosts or screech owls, they are barred owls. They mate over roughly two weeks about now.

If you are fortunate enough to see a brown bird a little bigger than a crow flying like a bullet, that's a Cooper's hawk or a rough-shinned hawk. I am a



bird feeder, but I know a lot of you aren't. If you are, watch out for your favorite birds. I have seen hawks scoping my feeders for birds to eat.

We are also privileged to have a Great Blue Heron who lives along the watershed somewhere. I saw it one day while I was walking.



It was perched on the roof of 395 Claire, looking for prey. Maybe we should name it. Harry? Harriet? Anyone?

Most of the songbirds are mating and nesting right now. If you can stand it, throw your dryer lint outside, and let them use it for nest lining.

Grand Opening of Dinosaur "Entrance Plaza"

Visitors will soon get a life-size prehistoric welcome when they arrive at Fernbank Museum of Natural History. The Museum is nearing completion on its iconic new Entrance Plaza, which features a family of bronze dinosaurs poised to greet visitors—many of them families as well—as they arrive.

The entrance plaza will provide an open atmosphere for outdoor enjoyment while instantly connecting visitors to nature and the prehistoric world, a journey that continues inside the museum as exhibitions, IMAX films and programs explore archaeology, paleontology, ecology, world cultures, and more.

The plaza, which will officially open on May 30, is the culmination of a major initiative to add more opportunities for visitors to engage with nature and further expand exhibition space beyond the walls of the museum. The forthcoming addition of an amphitheatre and a stage will help Fernbank meet the growing demand for outdoor programming, including performances and presentations.

"Fernbank Museum is the cornerstone of an environmental legacy that began over 100 years ago. The entrance plaza connects visitors with the beauty of the natural world as soon as they arrive," said Fernbank Museum's President & CEO, Susan Neu-



gent. "The scenery of the plaza also provides a natural setting for our new dinosaur family, which will welcome the families of visitors to Fernbank as they embark on a captivating exploration of nature, prehistory and culture."

Fernbank Museum is the first to reconstruct Lophorhothon atopus using the most current science to bring the fossils to life through a family of three bronze dinosaurs pausing for a drink in a streambed.

"This plaza is an exciting addition to the Museum, both for its beauty and for its ability to expand Fernbank's exhibitions and learning outdoors," said Fernbank's Vice President of Education, Christine Bean. "Fernbank's exhibition design team did a remarkable job highlighting two of our key areas of focus—the environment and

paleontology—which maintains Fernbank's commitment to the newest research. We can already tell what a hit the plaza will be by the number of visitors who take photographs in front of the fountain, even though the dinosaurs have yet to arrive."

What dinosaurs are featured in the entrance plaza?

The family of dinosaurs is from the species Lophorhothon atopus, a rare Southeastern hadrosaur that lived in the region that is today Georgia. Lophorhothon means "crested nose," and you can easily spot how these dinosaurs got their name.

How big was an adult Lophorhothon atopus dinosaur?

Adults weighed 6,000 pounds, measuring up to 35 feet long and nine feet tall. The young adult female in Fernbank's exhibition measures 24 feet long, and the two juveniles each measure about 12 feet long.

What did they eat?

These dinosaurs were herbivores and likely ate leaves and other vegetation.

How long ago did they live in Georgia?

Lophorhothon atopus lived 76-86 million years ago during the Cretaceous Period.

Did dinosaurs really have a "family life"?

Paleontological research of hadrosaurs reveals that they nested in large groups and continued to care for their young into their juvenile years.


Why did Fernbank choose this dinosaur species?

There are many reasons, including an opportunity to be the first museum to ever reconstruct Lophorhothon atopus, which was native to our region. Also, a family of dinosaurs relates well to the many families that visit Fernbank every day.

Who made the dinosaurs?

Fernbank's Vice President of Exhibitions, James Hays, researched, designed and sculpted the original models, which were then reproduced at life size using sophisticated imaging and technology. Fernbank's experts, including Hays, and staff scientist and VP of Education Christine Bean, consulted with area paleontologists and worked with local studios to assist with the project.



- 1 hour
- Between Midnight and 10 am
- 3 days a week, depending on address
- Odd-numbered addresses Tuesdays, Thursdays and Sundays
- Even-numbered addresses Mondays, Wednesdays and Saturdays The new rule does not apply to watering turf grass, which is still prohibited.

Customers can still hand-water for 25 minutes a day during the same times and on the same schedule as listed above. New landscaping can be watered up to three days a week on that schedule. Anyone wishing to water new landscape must register with the Outdoor Water Use Registration Program by going to the Urban Agricultural Council web site at www.urbanagcouncil.com.




